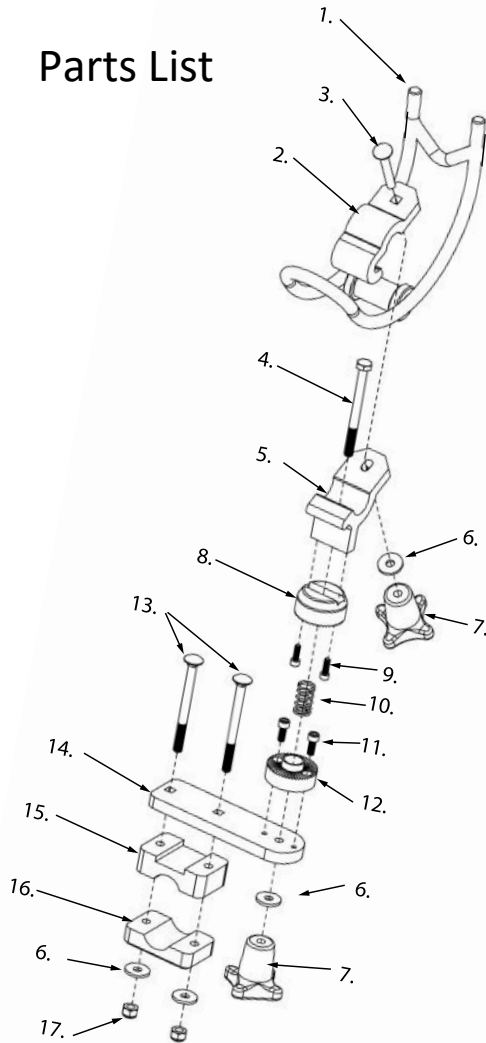

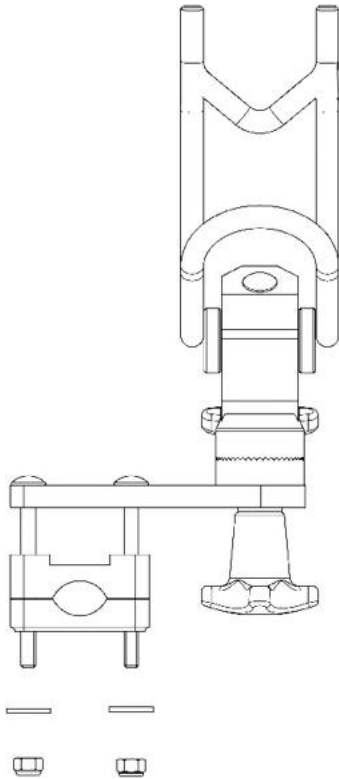

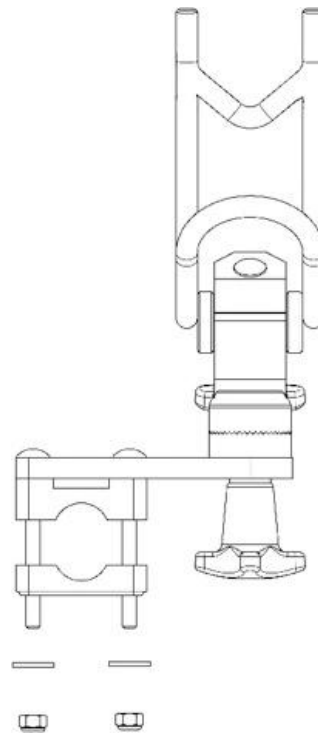

2. Use configuration in (Image 2) for ¾" to 1-1/2" Round tubing.

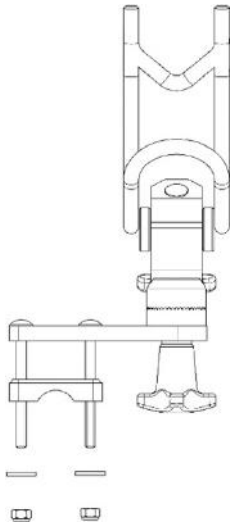
